In contrast, the number of super-rich people in Indonesia has increased 68% since 2016 when it was record at only 832 people. The richest official in Indonesia, Minister of Tourism and Creative Economy, followed by Prabowo Suffanto, Nadiem Anwar Makarim, Luhut Binsar Pandjaitan, and Airlangga Hartarto. Meanwhile, the status of the State Administrator's Wealth Report (LHKPN) for 5 (five) other officials is still in the verification process, namely Tahir, Muhamad Mardiono, Benny Laos, Wiranto, and Muhidin, for Echelon I officials, this was achieved by Suryo Utomo, an employee of the Ministry of Finance The 18 el of LHKPN compliance in various Ministries, officials, both executive, legislative and judicial, namely: In the Republic of Indonesia Ministry environment, the highest was 10 chieved by the Ministry of Health, namely 89.45%, while the lowest LHKPN Compliance was completed by the Coordinating Ministry for Political, Legal and Security Affairs), namely only 40.22%.

For the Indonesian State Administrator with the Largest Assets (2021). Minister of Tourism and Creative Economy (Menparekraf) Sandiaga Uno is currently the richest person among Indonesian state officials. According to data from the State Administrator's Wealth Report (LHKPN), Sandiaga Uno's total wealth reached IDR 10.617 trillion at the end of 2021. Sandiaga Uno's assets increased by around IDR 6.8 trillion compared to the previous year, where his wealth was recorded at IDR 3.815 trillion at the end of 2020.

Sandiaga Uno was appointed as Menparekraf on December 23 2020. Thus, this fantastic increase in wealth occurred after he served as minister for a year. The following is a complete list of the 10 richest officials according to LHKPN data for the 2021 reporting year:





Suryo Utomo also owns 5 other brands of motorbikes, and 5 cars, as well as land and buildings spread across Bogor, Bekasi and South Jakarta. In total, he has a wealth of around IDR 14.5 billion in 2021.

Ministries that comply most with LHKPN

Every year, the Corruption Eradication Commission (KPK) also routinely measures the level of LHKPN compliance in various official environments, both executive, legislative and judicial. Compliance is measured by the number of LHKPN reports with "complete" status, divided by the total number of officials who are required to report.

Within the ministry, the highest level of LHKPN compliance this year was achieved by the Ministry of Health (Kemenkes), namely 89.45%. This means that of all Ministry of Health officials who are required to report LHKPN, a total of 1,631 people, 89.45% have provided a complete report.

The lowest LHKPN compliance was achieved by the Coordinating Ministry for Political, Legal and Security Affairs (Kemenko Polhukam), namely only 40.22%. The number of officials required to report in the ministry led by Mahfud MD is only 92 people. 
